Wastewater treatment with plants: launch of the CARIBSAN project on 27 & 28 September



Caribbean cooperation to protect and enhance local natural heritage

On September 27 & 28, 2021, the virtual inauguration of the CARIBSAN project will be held by videoconference. This high-level event will bring together political leaders as well as all technical and institutional partners of the participating countries.

CARIBSAN is a Caribbean cooperation project that aims to deploy an innovative, environmentally friendly technology adapted to the tropical context for wastewater treatment using local plants.

The impact of wastewater is an environmental emergency in the Caribbean. The majority of the Caribbean population lives near a fragile aquatic environment that is subject to impacting uses, where sanitation infrastructures are often insufficient and lead to pollution that is dangerous for health

Plant-based sanitation in the Caribbean

CARIBSAN aims to promote and develop plant-based wastewater treatment throughout the Caribbean. In the French West Indies, wastewater treatment plants using local plants (Heliconia psittacorum "birds of paradise") have been demonstrating their effectiveness for several years. This nature-based technology has the advantage of being efficient, environmentally friendly, simpler and cheaper to manage than a conventional system and resistant to the climatic disturbances of our regions.
